Traffic report: The SID has now been installed at Maerfield Gate. There has been a significant reduction in vehicle speeds at Maerfield Gate, and a 10% reduction of speeding traffic at the Sandy Lane junction.

Speed limit at Stableford: It is unlikely that SCC Highways would review the speed limit. A possible solution to the problem of traffic speeds past the Stableford Bank junction might be to install a vehicle activated sign. Rob Steele will be asked for the names of recommended suppliers and some costs will be obtained.

Village signs for Stableford and Hill Chorlton: The new signs should be ready for collection this week. Cost estimates need to be obtained for mounting poles and installation for the Stableford signs.
